Kathleen Theisen, President called the meeting to order. The minutes from the last board meeting were presented to the group for approval. There were no revisions required.

The minutes were accepted by John Metz and seconded by Sharon Girard.

Old Business:

Membership Report: We have over 200 members. Kathleen Theisen suggested trying to attract the younger college teachers. Sharon Girard suggests having a collegiate chapter to increase our presence at colleges. Kathleen will talk about this to our college MTNA representative.

John suggested creating flyers regarding the CSMTA for distribution in the colleges and relevant businesses. Each chapter could post a flyer in their local area. Rena Kerimova suggested contacting middle and high school teachers. Diane Cooke suggested sharing ideas between chapters. She suggests contacting people one on one to recruit members. Sharon Girard stated that the Hartford chapter once had a membership flyer. Chapter presidents are asked to make an effort to contact independent teachers who do not belong to the chapter to increase membership.

Kathleen has a new digital logo for the CSMTA. Action Item: Kathleen will send it to the chapter presidents. CSMTA logo is now posted on the website and can be downloaded by anyone who needs it. Instructions are posted on the website.

We discussed having an 'official' address for CSMTA, but board members present felt that we should not change this. We will continue to use the President and Treasurer addresses as the official CSMTA addresses.

Kathleen will speak to Russell Hirshfield about starting a collegiate MTNA chapter at WCSU.

Fundraising: State-wide Play-a-thon was suggested by Kathleen Theisen.

State-wide Audition Program: Fairfield chapter does not participate In MAP. Kathleen would like to see more participation state-wide. Hartford and Middlesex/New London have excellent participation. Western chapter had 38 students participate this year.
